

ADULT MATCH MAKER "HALLOWEEN SELFIE COMPETITION" - TERMS & CONDITIONS -

2. To Enter:

Adult Match Maker members can login and upload a Halloween themed selfie to the designated upload and gallery page to enter into the competition. By uploading a selfie you are eligible to win prizes.
